## Texas Medical Board Relaxes Licensing Rules, Out-of-State Doctors Help Hurricane Harvey Victims

In its <u>Hurricane Harvey Response</u>, the Texas Medical Board relaxed its licensing rules for out-of-state providers.

# TMB Expedited Temporary Permits for Out-of-State Physicians & Other Practitioners

The TMB is issuing expedited temporary permits for out-of-state physicians assisting with the Hurricane Harvey emergency response. Applications will be reviewed and immediately expedited upon verification of good standing of the out-of-state physician's license.

Submit the <u>EMERGENCY VISITING PHYSICIAN TERMPORARY PERMIT FORM</u> to: TMBtransition@tmb.state.tx.us. Include "HARVEY" in the procedure section of the form.

#### Rules for the Temporary Permit

- Applying physicians must be sponsored by a licensed Texas physician. This
  requirement may be fulfilled by a facility based physician, such as a
  department director, where the visiting physician will be practicing.
- Applying physicians must be licensed to practice medicine in another jurisdiction and submit to a Criminal History Verification.
- The temporary permit is valid for 30 days.
- There is no charge for the permit.

#### Non-Physician Providers

Out-of-state non-physician health care providers who are not affiliated with a hospital may apply for an <u>EMERGENCY VISITING PRACTITIONER TEMPORARY PERMIT</u>.

The <u>Texas Board of Nursing</u> is also issuing temporary licenses for out-of-state nurses. The BON reports that it issued over 600 temporary licenses to out-of-state nurses from August 26th to September 1st.

The <u>Texas State Board of Examiners of Psychologists</u> is also issuing emergency temporary licenses to assist Hurricane Harvey victims. In fact, the Red Cross issued a call for mental health care practitioners to help those affected get through the intense crisis. The Red Cross reports that "We received over 5,000 applications

from health and mental health professionals interested in deploying with the Red Cross to support Hurricane Harvey."

# Governor Temporarily Suspends TMB Licensing Requirements for Hospital-Affiliated Providers

Texas Governor Greg Abbott temporarily suspends "all necessary statues and rules to allow health care providers employed by a hospital and licensed and in good standing in another state to practice in Texas in order to assist with the Tropical Depression Harvey disaster response operations."

The temporary suspension of TMB licensing requirements is in accordance with section 418.016 of the Texas Government Code, which allows the governor to "suspend the provisions of any regulatory statute prescribing the procedures for conduct of state business or the orders or rules of a state agency if strict compliance with the provisions, orders, or rules would in any way prevent, hinder, or delay necessary action in coping with a disaster." Tex. Gov't Code § 418.016.

#### Length of Suspension & Hospital Duties

The suspension is in effect until it is terminated by the Office of the Governor or until the Tropical Depression Harvey disaster declaration is lifted or expires. Hospitals have a duty to submit to the applicable licensing entity the name, provider type, state of license, and license identification number for each out-of-state provider they send. The providers' information can be emailed to: TMBtransition@tmb.state.tx.us.
